# Austria's Hallstatt village protests against mass tourism

Austria, Sept 01: Over the last weekend, Hallstatt village citizens in Austria have protested against mass tourism in this area by blocking the main road to the town. In spite of the fact that it has a population of just 800, it sees over 10,000 visitors within a day during the peak summer

season, SchengenVisaInfo. com reports. According to a Sky News report, on Sunday, locals blocked the main access to the tunnel to the village as a sign of protest against tourism. Austrian newspaper Salzburger Nachrichten said that the tunnel was closed for nearly 15

minutes. Holding placards with slogans such as "Think of our children" and "Radical frontiers for mass tourism," about 100 people gathered for the protest.

Residents of Hallstatt called for limits on the number of daily tourists and also for a ban on

tour buses after 17:00 local time.

This is not the first time that residents have called for action when it comes to mass tourism in this zone. In May this year,

the residents of Hallstatt built a wooden wall in order to block the views of the Alps and show their anger in this way.
